CRIMINAL COMPLAINT

The undersigned, of the Waukesha County District Attorney's Office, being first duly sworn on oath, upon information and belief, states that:

### Count 1: DRIVE OR OPERATE A VEHICLE WITHOUT OWNER'S CONSENT

The above-named defendant on or about Tuesday, June 4, 2019, at the area of Highway 67 north of Highway DR, in the City of Oconomowoc, Waukesha County, Wisconsin, did intentionally drive or operate a vehicle, without the consent of the owner, Mark Eilers, contrary to sec. 943.23(3), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

### Count 2: FELONY BAIL JUMPING

The above-named defendant on or about Tuesday, June 4, 2019, at the area of Highway 67 north of Highway DR, in the City of Oconomowoc, Waukesha County, Wisconsin, having been charged with a felony and having been released from custody under Chapter 969 Wis. Stats., did intentionally fail to comply with the terms of her bond, contrary to sec. 946.49(1)(b), 939.50(3)(h) Wis. Stats., a Class H Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than six (6) years, or both.

# Count 3: FAILURE TO COMPLY WITH OFFICER'S ATTEMPT TO TAKE PERSON INTO CUSTODY - PTAC, AS A PARTY TO A CRIME

The above-named defendant on or about Tuesday, June 4, 2019, at the area of Highway 67 north of Highway DR, in the City of Oconomowoc, Waukesha County, Wisconsin, as a party to a crime, did intentionally refuse to comply with an officer's lawful attempt to take her or her into custody and retreats or remained in a building or place and, through action or threat, attempted to prevent the officer from taking her or her into custody and while doing each of the above, remained or became armed with a dangerous weapon or threatened to use a dangerous weapon regardless of whether she or she had a dangerous weapon, contrary to sec. 946.415(2), 939.50(3)(i), 939.05 Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

### Count 4: FAILURE TO COMPLY WITH OFFICER'S ATTEMPT TO TAKE PERSON INTO CUSTODY

The above-named defendant on or about Tuesday, June 4, 2019, at the area of Highway 67 north of Highway DR, in the City of Oconomowoc, Waukesha County, Wisconsin, did intentionally refuse to comply with an officer's lawful attempt to take her or her into custody and retreats or remained in a building or place and, through action or threat, attempted to prevent the officer from taking her or her into custody and while doing each of the above, remained or became armed with a dangerous weapon or threatened to use a dangerous weapon regardless of whether she or she had a dangerous weapon, contrary to sec. 946.415(2), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

# Count 5: STRIKE POLICE/FIRE ANIMAL USING A DANGEROUS WEAPON - CAUSE INJURY

The above-named defendant on or about Tuesday, June 4, 2019, at the area of Highway 67 north of Highway DR, in the City of Oconomowoc, Waukesha County, Wisconsin, did intentionally strike an animal by using a dangerous weapon, knowing that the animal that is the victim is used by a law enforcement agency to perform agency functions or duties and caused injury to the animal, contrary to sec. 951.18(2m) Wis. Stats. and, contrary to sec. 951.095(1)(c), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

### Count 6: ATTEMPTING TO FLEE OR ELUDE AN OFFICER

The above-named defendant on or about Tuesday, June 4, 2019, at the area of Highway 67 north of Highway DR, in the City of Oconomowoc, Waukesha County, Wisconsin, while operating a motor vehicle on a highway, after having received a visual or audible signal from a traffic officer, federal law enforcement officer, or marked or unmarked police vehicle that the operator knew or reasonably should have known was being operated by a law enforcement officer, did knowingly flee or attempt to elude a traffic officer by willful disregard of the visual or

audible signal so as to endanger other vehicles, contrary to sec. 346.04(3), 939.50(3)(i) Wis. Stats., a Class I Felony, and upon conviction may be fined not more than Ten Thousand Dollars (\$10,000), or imprisoned not more than three (3) years and six (6) months, or both.

And furthermore, invoking the provisions of Wisconsin Statute 343.31(3)(d)1, upon conviction the department shall revoke the defendant's operating privileges for 6 months.

#### PROBABLE CAUSE:

And prays that the defendant be dealt with according to law; that the basis for complainant's charge of such offense is: Based upon the reports of Conversation Warden Adam Strehlow, of the Wisconsin Department of Natural Resources, and Special Agents Mitchell Ward, Bradley Kust and Nathan Peskie of the Wisconsin Department of Justice – Division of Criminal Investigation.

Warden Strehlow reports that on June 4, 2019, at the start of his shift, he was alerted to a suspicious vehicle that had been reported earlier that day by Anne Korman, Park Superintendent at the Kettle Moraine State Forest, who had contact with a vehicle at the Horse Rider's Campground, in the Town of Palmyra. Korman reported that she contacted the vehicle because it was parked near a campsite and had no proof of being registered for the site, and was also illegally parked. Korman spoke with a female in the front passenger seat of the vehicle. Korman reported that the female appeared to be dazed and nervous. Korman stated that after she spoke with the female subject, Korman returned back to her truck and the female then jumped into the driver seat of the vehicle and drove away.

Warden Strehlow reports that at approximately 4:16 p.m., he was on routine patrol at the Paradise Springs Nature Area, located off of Highway N, in the Town of Eagle, Waukesha County, Wisconsin. He observed a gray Dodge minivan parked in the far southeast corner of the lot. The description of the van matched the description of the vehicle encountered by Park Superintendent Korman earlier that day. Warden Strehlow was able to observe one female subject in the driver seat of the vehicle. He further observed that the side passenger sliding door was open. Warden Strehlow parked near the vehicle and observed that the vehicle did not have a State Park entrance sticker on the windshield, as required. Warden Strehlow then approached the vehicle to speak with the driver about not having a park entrance sticker.

Upon approaching the vehicle, Warden Strehlow observed that the driver's window was partially down and he announced himself as a State Game Warden. When the woman in the driver seat saw him, she jumped in her seat, as if she were startled. The woman said, "Oh shit, Hi, what's wrong?" At this time, Warden Strehlow was standing at the driver side window and could see that there was a man laying down in the middle row bench seat of the minivan, with his feet sticking out the passenger side sliding door. The woman repeatedly said, "Hey Nick, wake up."

Warden Strehlow asked the woman if he was okay and she stated, "Yes, he's fine." Warden Strehlow stated that the woman was yelling and that the man appeared extremely lethargic and barely moved his head. Warden Strehlow focused his attention on the man lying in the middle seat and during this time, the woman turned the vehicle on and put the vehicle in

reverse. Warden Strehlow yelled, "Ma'am, stop!" Warden Strehlow reports that he ordered her to stop the car several times. Warden Strehlow reports that he stepped back in order to avoid getting hit by the front of the vehicle. The female driver looked directly at the Warden, shrugged her shoulders and smiled, then put the car into drive and drove off. As the minivan started towards the exit, Warden Strehlow returned quickly to his squad. Warden Strehlow reports that the van did not stop at the stop sign leaving the parking lot, but turned north on Highway N.

Warden Strehlow drove out of the parking lot and activated his emergency lights and siren. The van was approximately one hundred fifty yards north of him on Highway N. Warden Strehlow accelerated to approximately sixty mph in an effort to catch the van. As the van attempted to make a sharp turn west of Highway N, approximately five-tenths of a mile north of the Paradise Springs parking lot, the vehicle lost control and skidded off the road into a gravel driveway. The driver then re-gained control and continued north on Highway N.

Warden Strehlow reports that they traveled north on Highway N at approximately eighty mph. Warden Strehlow was approximately one hundred yards behind the fleeing vehicle, in pursuit, for approximately two miles along this roadway.

Warden Strehlow reports that as the vehicle approached Highway ZZ, it slowed to approximately twenty mph. The vehicle then turned right onto Highway ZZ from Highway N, and rolled through a stop sign at approximately fifteen mph. Warden Strehlow observed that the side sliding door was closed at that point and the vehicle accelerated quickly, traveling eastbound on Highway ZZ.

Warden Strehlow reports that while traveling eastbound on ZZ, the vehicle was traveling at approximately sixty mph while going around two turns. On ZZ, between Highway N and Highway ZC, the fleeing vehicle crossed the center line and drove partially in the westbound lane.

As they approached Highway ZC, Warden Strehlow informed dispatch that he was aware there was road construction ahead on Highway ZZ. Warden Strehlow reports that the road construction stretched from Highway 67 on ZZ, west for approximately one half mile. Warden Strehlow reports that construction workers were resurfacing the pavement and had the westbound lane of ZZ completely closed in this area and flaggers were being used to let traffic through in the eastbound lane.

Warden Strehlow reports that they were still traveling at approximately sixty mph as they approached the construction zone. Warden Strehlow observed that the driver did not maintain her lane but crossed the center line several times. Warden Strehlow was advised that spike strips were being set out on Highway ZZ, at the beginning of the construction zone. Warden Strehlow was also advised at that point that the vehicle was listed as stolen.

Warden Strehlow reports that they came around a long bend on Highway ZZ and he observed a Waukesha County Sheriff's Deputy outside of his vehicle, preparing stop sticks. The deputy was parked on the far west end of the construction zone. Several bystander vehicles were lined up and stopped. The van veered to the left around the bystanders and the deputy's vehicle. The deputy was unable to set the spike strips in time. Warden Strehlow accelerated

and got within three car lengths of the vehicle. Warden Strehlow reports at that time, both he and the fleeing van were operating at the edge of the road, away from the closed lane. Speeds slowed to approximately thirty to forty mph. Road conditions turned to loose gravel in the construction zone. Warden Strehlow observed several construction workers and large trucks lined in the westbound lane of ZZ. About half way through the construction zone, a large construction truck moved from the westbound lane over into the eastbound lane, in an apparent attempt to cut the fleeing vehicle off. The van slowed to about fifteen mph and left the pavement and traveled to the right around the construction truck. Warden Strehlow followed the van and also left the road to avoid the truck. Once they were both around the truck, speeds increased to twenty-five to thirty mph. They continued eastbound on Highway ZZ and passed the entrance of Ottawa Lake State Park. While passing the park entrance, several construction workers were in the westbound lane, yelling at the van and making hand signals.

Warden Strehlow reports that they continued to Highway 67 and the van came to a brief stop at a stop sign, due to traffic from both directions. The van turned left to travel north on Highway 67, requiring several other vehicles traveling on 67 to stop to avoid a collision. Once on 67, speeds accelerated quickly to seventy mph.

Warden Strehlow further reports that while driving on Highway 67 between Highway ZZ and Highway C, he observed the male subject getting up and falling down several times in the back seat of the van.

Warden Strehlow reports that as they passed Highway C, speeds were sixty-five mph and the traffic was medium. The male subject could be seen in the back of the van making dramatic movements, it appeared that he was digging around, looking for something.

Warden Strehlow reports that as they traveled northbound on Highway 67 near Hunter's Lake Road, the vehicle operated in the southbound lane to pass multiple vehicles. They continued north on 67 and crossed Highway 18. Speeds slowed to forty-five to fifty-five mph through the intersection. Once through the intersection, speeds went back up to sixty to seventy mph. Warden Strehlow reported there were multiple squads behind him that had joined in the pursuit.

Warden Strehlow reports that between Upper Genesee Lake Road and Delafield Road, a squad was observed on the west side of Highway 67 and dispatch advised that stop sticks were deployed. Warden Strehlow reports that the vehicle swerved right to avoid the stop sticks, but that both driver side tires were deflated. Warden Strehlow reports that more stop sticks were deployed at Delafield Road. As they approached Delafield Road, Warden Strehlow observed the right lane to have numerous stopped vehicles. Warden Strehlow went to the right of the vehicles, on the shoulder and a Sheriff's deputy behind him went to the left. As they crossed the intersection, the van hit more stop sticks and the deputy's vehicle got directly behind the van. Warden Strehlow was now the second vehicle in the pursuit. The deputy was behind and on the passenger side of the van and Warden Strehlow was behind and on the driver side of the van.

Warden Strehlow reports that additional stop sticks were deployed at Blue Ridge Road. As they passed Blue Ridge Road and began the incline towards the I-94 overpass, the deputy got

into position to attempt a Pit maneuver. They were traveling at fifteen to twenty mph at the time. As the deputy got closer to the vehicle, Warden Strehlow observed that the male subject leaned out of the front passenger seat with his waist on the door frame and was holding a black handgun in his hand. Warden Strehlow reports that the male initially pointed the gun at his squad and straight back and then immediately shifted the gun to aim at the deputy that was closest to him. Warden Strehlow reports that he drew his service weapon and aimed it at the passenger side of the vehicle through the windshield. Speeds were approximately ten to fifteen mph. The deputy swerved and the male passenger moved back inside the van. The deputy rolled down his driver side window and fired two shots at the van. The van was still moving forward on the rims and it swerved into a guardrail and came to a stop on the east side of the I-94 overpass.

Deputy Jennifer Wallschlaeger, of the Waukesha County Sheriff's Department, was the primary crisis negotiator during this incident. Deputy Wallschlaeger provided a statement indicating that at approximately 4:30 p.m., on June 4, 2019, she heard a pursuit broadcast over the police radio. She learned that a DNR Warden was in pursuit of a car stolen from Germantown and that there were possible guns inside of the stolen car.

Deputy Wallschlaeger further stated that she listened for a few minutes and then heard someone broadcast on the air "He's got a gun!" and then a different voice broadcast "Shots fired!" Deputy Wallschlaeger then began to respond to the area where the pursuit ended. While on the way, she contacted dispatch and was provided with a telephone number for the suspect. Wallschlaeger called the number while still driving toward the scene.

Deputy Wallschlaeger reported that a male subject answered the phone. This subject was later identified as Nathan J. Halfman, DOB:10/14/1981. Wallschlaeger identified herself as a negotiator to him. He asked if she was on scene and she replied she was not, so he told her to call back when she was on scene and then hung up the phone. Wallschlaeger waited about two minutes and called Halfman again. He asked if she was on scene and she replied she was getting close, but that traffic was busy. Halfman screamed that he needed her on scene and that she should call him back when she was there. Deputy Wallschlaeger reports that Halfman sounded agitated and excited. Wallschlaeger asked him if he had anyone in the car with him and he responded that he had a hostage and then hung up the phone.

Deputy Wallschlaeger further reports that as she approached the area, she called Halfman again. Wallschlaeger told Halfmann that she was on scene, stuck behind squad cars. Wallschlaeger asked the suspect his name and the name of the hostage. Halfmann responded that she did not need to know their names and demanded water. Deputy Wallschlaeger reports that Halfmann still sounded excited and agitated. He told her that he had a hostage and that she (the hostage) had nothing to do with what happened. He again demanded water and hung up.

Deputy Wallschlaeger then set up at the scene and called Halfmann again. This time, a female subject answered the phone. She was later identified as Kalin O. Sunde, DOB:10/31/1987. Sunde told Wallschlaeger that the suspect had a gun to her head. Wallschlaeger asked the female subject for her name, but Wallschlaeger could not clearly hear the response. Deputy Wallschlaeger reports that because the phone connection seemed weak, she asked Sunde if

she had her own phone and also offered to get a better phone for them to use. Sunde then hung up.

Deputy Wallschlaeger called the phone number again. This time, Halfman answered the phone and it appeared he had his phone on speaker function because Deputy Wallschlaeger could hear both Halfman and Sunde talking. Deputy Wallschlaeger reports that both of them were yelling inside the van and that Halfmann was demanding water and cigarettes. Sunde yelled that Halfman had a gun to her head. Deputy Wallschlaeger reports that Halfman seemed more agitated and often talked over Sunde. Deputy Wallschlaeger asked them what they needed and they both said they were thirsty and needed water. Both also said the phone was going dead.

Deputy Wallschlaeger waited for about two minutes and then called back. Halfman answered and again seemed to have the phone on speaker. Sunde said that her two month old baby was in the car. Deputy Wallschlaeger asked Sunde if the baby was hers and asked if the baby was hurt. Sunde didn't answer, so Wallschlaeger then asked if anyone in the car was hurt. Both Halfman and Sunde stated that Halfman had been shot in the knee. Deputy Wallschlaeger reported that she believed Sunde said that she put a tourniquet on the wound. Wallschlaeger asked if they needed medical attention and Sunde responded that they did not because of the tourniquet and they hung up again. Deputy Wallschlaeger reports that she then advised Lieutenant Anderson about the two month old baby in the car. Deputy Wallschlaeger reported that the possible presence of the baby inside the car limited what techniques (gas, ramming, etc.) could be used by law enforcement to get the suspects out of the car.

Deputy Wallschlaeger reports that the negotiations with Halfman did not go well. Halfmann did not behave in a rational manner and was extremely agitated. She was unable to build rapport with either Halfman or Sunde. Both Halfman and Sunde would just make demands and then hang up the phone.

Deputy Wallschlaeger further reports that she was very concerned about the safety of the baby in the van and during subsequent calls, pressed Sunde and Halfman for information about the baby. Deputy Wallschlaeger noticed that whenever she asked too many questions about the baby, they would hang up. Deputy Wallschlaeger reported that she never heard any crying or other noises associated with a baby and that the story about who the child belonged to began to change. Initially, Sunde stated the baby was hers but then later said they were babysitting someone else's baby. Deputy Wallschlaeger asked Sunde and Halfman to wake the baby up so that Deputy Wallschlaeger could hear it cry, but they refused and hung up. Other officers determined that Sunde's children had been taken from her by Child Protective Services. Deputy Wallschlaeger further noted that Sunde and Halfman made no demands for diapers or formula for the baby. Deputy Wallschlaeger suspected they were lying about the baby being in the van.

Deputy Wallschlaeger further reported that Sunde and Halfman behaved the same way when she would ask them questions about Halfman's gunshot wound. After several calls, the story continued to change until Sunde finally said that Halfman had only been nicked, not actually shot.

Deputy Wallschlaeger reported that through the negotiation, Sunde did not seem to be very agitated and displayed no fear in her voice. Both Sunde and Halfman's demeanor changed at points in the investigation and Wallschlaeger suspected they were both using controlled substances during the negotiation. She noted that on one call, they would both seem very hyper and agitated, but on the next call, they would seem to be lethargic and more sedate. Deputy Wallschlaeger concluded that Sunde was more likely a co-actor than a hostage and willingly participated in the stand-off with police.

Special Agent Nathan Peskie reports that on June 5, 2019, he interviewed Milwaukee County Sheriff's Deputy Brandon Scales. Deputy Scales provided a statement indicating that he was working his normal shift, 4:00 p.m. to 12:00 a.m., on June 4, 2019. He reports that he was at a substation when he heard over the "chase channel" about a pursuit involving a mini-van that had been stolen in a burglary in the Village of Germantown. Deputy Scales recalled that a 9 mm firearm was also taken and that the occupants of the vehicle were considered armed and dangerous.

Deputy Scales stated that at about 5:28 p.m., there was a request made by the Waukesha County Sheriff's Department for additional armored vehicles to respond after the vehicle was stopped and a stand-off began. Deputy Scales and Deputy Geason responded with the Milwaukee County Sheriff's Bearcat armored vehicle. Deputy Scales stated that while traveling to Oconomowoc, the were given a safe route of travel to the command post and then were assigned to pull up alongside the Waukesha County Bearcat armored vehicle, which was directly behind the suspect vehicle.

Deputy Scales reports that upon getting in that position, he observed the rear windows of the suspect vehicle were heavily tinted and it appeared as though the windows were covered with blankets or clothing. Deputy Scales reports that he could not see any persons inside the vehicle, that he could just see there was movement inside but he could not see the suspects.

Deputy Scales further stated that at one point, the male subject pointed a small black semi-automatic handgun out of the driver side window and pointed it directly at the Milwaukee County Sheriff's Bearcat. The suspect did not fire the handgun at that point. Negotiators advised that the suspect was wavering between surrendering and not surrendering throughout the incident.

Deputy Scales further reports eventually it was decided to deploy gas into the van. Deputy Scales reports that he used public announcement system in his Bearcat to make announcements to the occupants of the van, at the request of the Waukesha County Sheriff's Department. Deputy Scales reported that he said, "Police, you are under arrest, come out the driver side door with your hands up" over the PA system. Deputy Scales reports that he made the same announcement about five or six times. After no movement in the vehicle, the gas was deployed into the vehicle.

Special Agent Bradley Kust, indicates that he interviewed Acting Detective Christopher Bellows, of the Menomonee Falls Police Department, who is a member of the Joint Waukesha County Metro Drug Unit and an operator on the Waukesha County Tactical Enforcement Unit. Detective Bellows stated that on June 4, 2019, he was in his office at the Metro Drug Unit when the pursuit of the van with Nathan Halfman and Kalin Sunde was initiated. Detective

Bellows monitored the pursuit until someone broadcast "Shots fired." The Tactical Enforcement Unit was then requested to respond to the scene. Detective Bellows did travel to the area of Highway 67 and 1-94 and then moved to a location of a marked patrol squad that was stopped behind the suspect vehicle, described as a light colored, older model minivan with tinted windows. Detective Bellows observed that Waukesha County Sheriff's Deputy Scott McDonnell's squad was stopped about five to ten feet behind the van and there was a second marked squad behind Deputy McDonnell's squad. Detective Bellows reports that he conducted surveillance on the van and observed the rear passenger windows of the van were slightly open. Through the windows, Detective Bellows saw sheets draped over the headrest of the front seats to the back of the back seats, that formed a canopy inside the van between the rows of seats. Detective Bellows could see at least one person who was moving inside the van at this time.

Detective Bellows further stated that he remained on scene for several hours and that it became dark outside. Detective Bellows stated that at one point, gas was deployed into the van and Halfman and Sunde exited the passenger side of the van. Detective Bellows saw two fellow tactical officers advance toward the minivan and then heard shots being fired. Detective Bellows saw both Halfman and Sunde moving during the shooting and then saw Halfman fall to the ground. Detective Bellows stated that Sunde continued to run toward the east side of Highway 67.

Detective Bellows reports that he focused on Sunde, who crossed the guardrail on the east side of Highway 67. Detective Bellows was about fifteen feet behind Sunde and she struggled to climb a chain link fence on the side of the overpass. Sunde cleared the fence and fell to the base of the overpass. Detective Bellows and Deputy Van Ells climbed over the fence but stayed on the top of the overpass. Detective Bellows reports that Sunde began crawling northeast through the tall grass at the base of the overpass. Detective Bellows reports that Sunde was in tall grass and he could not see her, but could track her travel by the movement of the grass.

Detective Bellows reports that other officers moved towards Sunde from other positions. Detective Bellows reports that he called out to Sunde and started talking to her. Sunde replied and Detective Bellows reports that he talked to Sunde for about ten minutes while other officers were forming a plan to arrest her. Detective Bellows reports that he tried to convince Sunde to surrender herself by calming her and teiling her she could get help. Detective Bellows reports that Sunde was receptive but also said that she had a knife and refused to drop it. Detective Bellows asked her to drop the knife about on half dozen times. Detective Bellows told Sunde that officers couldn't help her or approach her if she had a knife. Sunde then threatened to stab the police dog that was present, if the dog approached her. Detective Bellows reports that Sunde said, "Don't make me stab the dog, I'm not dropping the knife,"

Detective Bellows continued to talk to Sunde and asked her if she were cutting herself. Sunde said she was not cutting herself but refused to show Detective Bellows the knife. Detective Bellows then offered to let Sunde talk to Halfman if she would drop the knife but Sunde continued to refuse.

Detective Bellows reports that another officer then threw a gas canister toward Sunde's location and Sunde started to cough and vomit. Detective Bellows told Sunde she would get

more gas if she didn't drop the knife. Sunde knelt, facing Detective Bellows, with her head down and wiped her eyes with her left hand. Sunde kept her right hand next to her right knee and Detective Bellows could not see what she held in her hand. Detective Bellows told Sunde to show both hands. Sunde said that she was raising both hands, but in reality, she kept her right hand next to her right knee.

Detective Bellows stated that another gas canister was deployed within a couple of feet of Sunde and Sunde got up and started walking towards officers on I-94. Detective Bellows could not see Sunde's right hand and Sunde was saying "You're going to have to kill me." The officers on I-94 backed away from Sunde, as she approached the shoulder of the highway. Other officers then deployed a less-lethal impact round that struck Sunde in the lower back or buttocks area. Sunde screamed but continued walking across the highway.

Detective Bellows reports that he started moving down to the area where Sunde was and when he got down there, he observed that Sunde was in custody. Detective Bellows heard Waukesha County Sheriff's Deputy Kurt Thompson say "Find whatever she stabbed the dog with" so Detective Bellows backtracked, but did not find anything.

Officer Bloch, of the Germantown Police Department, reports that on June 3, 2019, at approximately 4:04 p.m., the Germantown Police Department received a telephone report from adult citizen-witness Jordan Stephan, DOB: 04/29/1987. Stephan reported that he arrived at his parent's residence and noticed the home had been burglarized and that there was a television and other items missing.

Officer Bloch responded to the residence located at N98 W17840 Lilly Court. Stephan was standing outside on the driveway. Stephan identified the residence as belonging to his mother, Christine Eilers and his step-father, Mark Eilers. Stephan stated that his mother and step-father were in Las Vegas and he was at the home to return a tool that he had borrowed but found that the residence appeared to be in a different condition that when he had last seen it on Saturday morning. Stephan stated that he walked around and saw a television was gone and noticed a vehicle missing from inside the garage. Stephan then contacted his mother and confirmed that a burglary must have occurred.

The missing vehicle was identified as a 2000 Dodge Caravan, registered to Mark Eilers. Officer Bloch reports that the vehicle was entered as stolen. Based on information and belief, Mark Eilers did not give anyone permission to operate the vehicle.

Detective Sergeant Penny Schmitt, of the Germantown Police Department, further reports that on June 4, 2019, the Waukesha County Sheriff's Department contacted the Germantown Police Department indicating they were involved in a vehicle pursuit involving shots fired on Highway 67 and I-94, in the Oconomowoc area, with the vehicle stolen in this incident. Detective Sergeant Schmitt later spoke with Detective Chris Kohl, of the Waukesha County Sheriff's Department, and confirmed based on make, model, color and VIN that the vehicle was in fact the stolen vehicle from the Eilers' in Germantown. Detective Sergeant Schmitt also confirmed that the handgun, described as a Taurus 9 millimeter, was taken in the burglary and was also involved in the incident in Oconomowoc.

Detective Sergeant Schmitt made telephone contact with the original complainant of the burglary, Jordan Stephan. Stephan agreed to meet with Detective Sergeant Schmitt for an interview.

Detective Sergeant Schmitt asked Jordan Stephan if anyone was with him when he went to his parent's residence and he initially said no. Detective Sergeant Schmitt asked him if anyone else would have known that his parents were out of town during the time of the burglary and he stated, "Umm...maybe Kalin Sunde." Stephan admitted that he met Sunde over an internet escort website a few years ago. Stephan admitted that he had contact with her again on June 1, 2019 and that he took her to his parent's house somewhere between 2:00 a.m. and 3:00 a.m. on Sunday, June 2, 2019. Stephan indicated that it was possible that Sunde could have seen him enter the code for the garage door. Stephan believes that he told Sunde his parents were out of town.

Special Agent Ward reports that on June 5, 2019, at approximately 3:15 p.m., he interviewed the defendant, Kalin Opal Sunde, DOB:10/31/1987. Sunde was advised of her constitutional rights and waived the same, agreeing to give a statement. Sunde stated that prior to being taken into custody, she was in the company of her boyfriend, Nate Halfman. Sunde stated that she had known Halfman for about six months and that she and Halfman intended to drive to Fond du Lac, Wisconsin with a half-ounce of cocaine, six to fourteen grams of heroin, and a smaller amount of meth. Sunde stated that the meth had been left over from one once of meth that she had recently obtained. Sunde stated that they had made a trip to Fond du Lac with narcotics on an earlier occasion.

Sunde stated that they did not continue to Fond du Lac because it wasn't going to be worth the trip because her drug customers there did not have enough money. Sunde explained that meth was "her thing" and that she would purchase a ball of meth for \$150.00 and then double her money after selling the meth. Sunde also admitted that she used heroin "off and on."

Sunde stated that on the way to Fond du Lac, she and Halfman stopped at Horse Rider's Park in Palmyra, Wisconsin, after picking up some heroin and crack cocaine in Milwaukee. While at the park, Halfman was sleeping in the back of the van. Sunde stated that she wanted to leave but Halfman didn't. Sunde stated that she was able to get the keys for the van from Halfman and she drove to Rainbow Springs and pulled over. Sunde stated that they were approached by "Park Police." Sunde stated that the officer approached the driver side of the van and told her to get out. Sunde stated that Halfman was still in the back of the van and told Sunde "Drive, drive, drive." Sunde stated that Halfman was armed with a black 9 millimeter semi-automatic pistol at this time and that he was holding it in his hand.

Sunde stated that she drove off and that the park police turned on his lights and siren and gave chase. Sunde stated that she thought about pulling over during the pursuit, but that she did not want to be in the middle of whatever Halfman would do. During the pursuit, Sunde stated that Halfman pointed the gun out of the passenger window and fired it at the police. Sunde stated that the police did fire back. Sunde stated that neither she nor Halfman were struck during the gun exchange.

Sunde was asked about the pursuit and stated that she recalled driving over stop sticks that had been placed in her path by the officers. Sunde stated that once the van came to a stop,

Halfman started to "freak out" and began putting blankets up in the windows so that the officers could not see in. Sunde stated that she could hear officers giving verbal commands to exit the auto. Sunde stated that after the van came to a stop, she called 9-1-1 from her phone because Halfman wanted to talk to a negotiator. During the negotiations, Halfman asked for cigarettes, water and marijuana to be brought to them. Sunde admitted that there was not a child present in the van, but that it was Halfman's idea to tell police that there was a child in the van in hopes that the police would not approach. Sunde stated that she "went along with it."

Sunde further stated that Halfman made several statements that he didn't want to go back to prison and that he would shoot at officers and her. Sunde stated that Halfman did hold the pistol to her head at various times. Sunde stated that she just tried to keep Halfman calm but that she did believe that Halfman would shoot her. Sunde stated that Halfman was injecting cocaine during the standoff.

Sunde further stated that at one point, Halfman crouched down by the driver seat and pulled the van forward by using his hand to depress the gas pedal. After moving a short distance forward, tear gas came into the van through the window. Sunde stated that they both got out of the rear passenger door and then Halfman was holding a gun to her head. Sunde stated that she ran down a hill and that she fell and rolled down the hill. Sunde stated that she did hear gun fire afterwards, but did not see what happened to Halfman. Sunde states that she got up and ran away because she is afraid of the police.

Sunde stated that she was lying down in tall grass when she was located by officers. Sunde stated that she could hear commands, but did not comply. Sunde stated that she could hear a dog and officers were telling her to come out of they would send the dog. Sunde reported that she removed an underwire from her bra and wrapped it around her hand to "defend herself" from the dog. Sunde states that as officers were giving her commands, she threatened to stab herself and officers because she was afraid of the dog. Sunde stated that she just wanted the police to come and get her. Sunde stated that she did not remember striking the dog but that after the dog bit her, she was taken into custody and taken to the hospital.

Regarding the van which Sunde was driving during the incident, Sunde stated that it belonged to one of her customers. Sunde stated that this is a customer that pays her for sex and that the customer owed \$1,000.00 to her. Sunde stated that she was aware of the fact that the customer and his father were in Las Vegas and that Halfman overheard this conversation and knew that the home would be unoccupied. Sunde stated that it was Halfman's idea to go to the customer's home and take property to satisfy the outstanding debt.

Sunde stated that she went to the house with Halfman and went inside to make sure that he didn't "trash" the place. Sunde admitted that property was taken and that Halfman found a 9 millimeter pistol and keys to the van.

Sunde admitted that she was the one who drove the van away from the victim's home.
