

BJ stated that at this point, he was face to face with the defendant when the defendant suddenly punched him in the face. BJ stated that the defendant then punched him two additional times before several people intervened. BJ stated that he could feel blood coming from his nose. BJ stated that at some point the defendant left before police arrived.

MA was also interviewed by Police. MA stated that during the middle innings of the game she showed the defendant a picture of a bulldog on her phone that she said represented how she felt. The defendant responded that the picture should of looked disinterested instead of angry. MA believed the defendant was talking about her appearance at her job. MA stated that she took offense to the comment and told BJ. MA stated that BJ tried to talk to the defendant away from the group but the defendant was unwilling.

MA stated that when the game was over and they were exiting their seats, BJ once again asked the defendant to talk. MA stated that the defendant did apologize to her but immediately reiterated that she looked disinterested. MA stated that BJ and the defendant started going back and forth with insults. MA stated that BJ and the defendant were face to face when things quickly escalated and the defendant lunged at BJ. MA stated that she moved away from the two and when she looked back she saw several people separating the two with BJ bleeding from the his nose.

The defendant was subsequently arrested by Milwaukee Police. During a Mirandized interview of the defendant by Det. Schimmels, the defendant stated that he has known BJ and MA for over a year. The defendant stated that BJ approached him at the game and asked him if he would like to sit with them as he had extra tickets. The defendant stated that around the sixth inning, MA showed him a photo of a bulldog and stated it represented how she felt. The defendant stated that the photo should have looked disinterested. The defendant stated that he teased MA by saying that she should have shown a picture of Jay Cutler. The defendant stated that MA responded to him in what he thought was a joking manner.

The defendant stated that the game continued without incident until the ninth inning. The defendant stated that BJ told him that they needed to go talk and he responded that he wanted to watch the end of the game and would talk after it was over. Once the game was over, the defendant stated that everyone began leaving their seats. The defendant stated that as they were reaching the concourse, BJ asked the defendant to talk again. The defendant stated that BJ told him that MA was angry at the comment that he had made earlier. The defendant stated that he was just "messing" with her and that he then apologized to MA. The defendant stated that the three then continued to talk about work and that he and BJ then began exchanging insults.

The defendant stated that BJ then got face to face with him and made a threat. The defendant stated that he thought BJ was going to hit him so he instinctively stepped back and punched BJ twice in the face. The defendant stated that they were almost immediately broken up and he observed that BJ's nose was bleeding and his eye was swollen. The defendant stated that MA then yelled "what the fuck". The defendant stated that BJ said they needed to get the police. The defendant stated that he was unsure what to do. The defendant stated that a couple of the people that were at the game with them told him he should get out of there. The defendant stated that he then left with his friend.
